All items are available for your examination prior to bidding. Your bidding will signify that you have examined the items as fully as you desire, or that you have chosen not to examine them. Our goal is to provide prospective bidders with accurate (as possible) and detailed information. We recommend that prospective bidders examine all items in which they have an interest. If you require absolute certainty in all areas of authenticity; and the results of your evaluation leave uncertainty in your mind; we recommend you do not bid on the item in question.

Payment must be made by cash (Auction Location or Office), bank wire transfer, Visa, MasterCard, Discover or American Express. Payment for all purchases is expected at the time of purchase.
